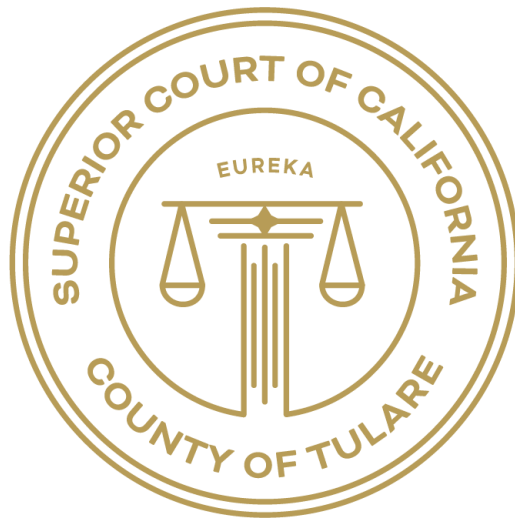


# Tulare County Superior Court Bail Schedule



November 7, 2024

## **General Principles of Bail and Pretrial Release**

1. The purpose of this bail schedule is to fix an amount upon which a person who is arrested without a warrant may be released from custody prior to appearance in court. Penal Code § 1269b, subd. (c) requires the Superior Court Judges of every county to prepare, adopt and annually revise a uniform schedule of bail for all felony and misdemeanor offenses. Pen. Code § 1269b, subd. (e) instructs the judges to consider the seriousness of the offense in adopting the bail schedule. Pen. Code § 1270.1, subd. (a) requires a court hearing before anyone arrested for certain offenses can be released on (a) his or her own recognizance, or (b) on bail in an amount that varies from the established county bail schedule.
2. After a defendant's first appearance in court, the amount of bail or whether to release someone on their own recognizance will lie in the sound discretion of the Court. If the Court does set bail, it may be greater or less than the amount set forth in the bail schedule, subject to the provisions of Pen. Code § 1275. In setting bail, the judge is required under Pen. Code § 1275 to consider the protection of the public, the seriousness of the offense charged, the previous criminal history of the defendant, and the probability of his or her appearing at a future court hearing. Public Safety is the primary consideration in setting bail.
3. Persons not entitled to release on bail are those charged with the following crimes: capital offenses (murder with special circumstances) and certain violent felony offenses "when facts are evident or the presumption great" that a person is a danger to the public. In either situation, the Court must find by clear and convincing evidence that there is a substantial likelihood the person's release would result in either great bodily harm to others, or the person has made a threat to do great bodily harm to another, and there is a substantial likelihood that the person would carry out the threat if released. (Article 12, California Constitution; Pen. Code § 1270.5; *In re Humphrey* (2021) 11 Cal. 5th 135, 238.)

4. The California Supreme Court has ruled that detention in jail before trial should be limited to those cases where there is clear and convincing evidence that an individual defendant is either a flight risk or poses a danger to public safety. (In re Kenneth Humphrey (2021) 11 Cal. 5th 135, 238.) These risk factors must be evaluated by the reviewing court. All defendants eligible for bail should be considered for own-recognizance release unless the Court makes an individualized determination that the defendant is either a flight risk or poses a danger to public safety. The Court should further consider conditions of release that minimize such risks. Pre-trial detention is only permissible if there are no less-restrictive conditions of release that will satisfy the state's interest in protecting the public and ensuring the defendant's appearance in court. If the Court is going to require the posting of monetary bail, it must consider the defendant's ability to pay the stated bail amount and may not effectively detain the defendant solely because the arrestee lacked the resources to post bail. (Id. at 143.)

**Tulare County Felony Bail Schedule**  
**General Information**

1. Pursuant to the requirements of Pen. Code § 1269b, this misdemeanor and felony bail schedule is adopted by the Superior Court of Tulare County and is to be utilized in setting bail for the release of persons arrested on felony charges, without warrant, for the alleged commission of any bailable offense.
2. Bail shall be set according to the bail schedule at the time of booking by the booking officer, at the time of arraignment in Superior Court, and on all arrest warrants, unless a magistrate in his or her discretion, determines a different amount of bail is appropriate or grants a request for release on own recognizance or a request to increase or lower bail pursuant to Pen. Code § 1269c.
3. This schedule shall supersede all prior felony bail schedules in Tulare County and shall become effective November 7, 2024. This bail schedule will be revised annually in accordance with Pen. Code § 1269b, subd.

(c), unless it is re-adopted without revision.

4. The jailer and clerks of the Superior Court are hereby authorized to accept bail for release of persons held in custody on felony charges in the amount of bail as set forth in accordance with this schedule.
5. Pursuant to Pen. Code § 1269c, if a peace officer has reasonable cause to believe that the amount of bail set forth in the schedule of bail for that offense is insufficient to assure defendant's appearance, the peace officer shall prepare a declaration in writing, under penalty of perjury, setting forth the facts and circumstances in support of the peace officer's belief and file it with a magistrate. Similarly, the arrested person, either personally or through his/her attorney, friend, or member of his/her family, may make application to a magistrate for release on bail lower than that provided in the schedule of bail or on his/her own recognizance within eight (8) hours after booking. If no change in bail is approved by the magistrate within eight (8) hours after booking, bail shall be set according to the bail schedule.
6. Bail for release from custody may be given in cash or by a properly executed property bond approved by the Court after a hearing or by a surety bond executed by a certified surety insurer. (*Sawyer v. Barbour* (1956) 142 Cal. App. 2d 827, 300.)
